Incident Summary:

The Cybersecurity and Infrastructure Security Agency (CISA) continues to monitor the evolving Coronavirus Disease, also known as COVID-19, situation closely. CISA is taking part in interagency and industry coordination calls and working with critical infrastructure partners to prepare for possible disruptions to critical infrastructure that may stem from widespread illness.

FEMA reports approximately 17,396,943 (+290,936 in the past 24 hours) cases and 675,060 (+6,150) deaths worldwide. In the U.S. there are approximately 4,601,526 (+58,947) cases and 154,002 (+1,132) deaths.

Key Points:

CRITICAL INFRASTRUCTURE IMPACTS:

HEALTHCARE AND PUBLIC HEALTH

The CDC says that the virus is on track to become one of the leading causes of death in the U.S. in 2020.

As of 02 Aug, California has recorded more than 508,000 cases, becoming the first state pass half a million cases.

DC: Reported 79 new coronavirus cases, no new deaths, and a 3.9 percent positivity rate on 31 Jul, according to media sources.

While D.C. saw its improvement as the average number of new cases fell over the past week, the trend is increasing in Virginia and Maryland.

VA: The Virginia Department of Health is reporting 91,782 total cases of coronavirus in the commonwealth as of 02 Aug, up from 90,801 reported 01 Aug, a 981-case increase.

AZ: State health officials reported a significant drop in cases and deaths. The new numbers bring the state's documented totals to 178,467 confirmed cases and 3,765 known deaths.

SC: The State Department of Health and Environmental Control announced an 18.5 percent positivity rate for new coronavirus tests on 01 Aug.

Mississippi, Montana, and Nevada all had single-day record increases on 31 Jul.

TRANSPORTATION SYSTEMS

(Aviation)

United Airlines plans to resume service on more than 25 international routes in September, offering flights to including Asia, India, Australia, Israel, and Latin America. The airline will still be flying only 37 percent of its overall schedule compared to the previous year.

(Mass Transit and Passenger Rail)

The American Public Transportation Association reports nearly one-third of public transit agencies have been forced to furlough employees or are planning to do so, and more than that have had to delay capital projects.

ACTIVATIONS AND DECLARATIONS

GA: State officials signed two executive orders extending existing policies regarding the pandemic. One extends the Public Health State of Emergency through 15 Sep; the other extends through 15 Aug safety measures such as banning gatherings of more than 50 people unless social distancing can be maintained and requiring sheltering in place for those living in long-term care facilities.

VA: In Arlington County, groups of three or more people are now banned from gathering on some streets and sidewalks under a new emergency order adopted by the Arlington County Board on 31 Jul. The new ordinance only applies to areas posted with the restrictions and is an attempt to mandate social distancing for the county. Pedestrians are still required to keep at least six feet of space between one another.

Thirty-one states/territories have issued mandates for facial coverings; three states/territories have issued partial/regional mandates for facial coverings, but no state-wide mandates; fifteen states/territories have issued regional mandates for face coverings, but no state-side mandates; two states/territories have no mandates, and local

orders are not enforceable; five states have no mandates.

Zero states and territories have complete stay-at-home orders in place. Four states have stay-at-home orders; however, only limited movement restrictions. Two states lifted state-wide orders, but maintain regional stay at home orders. Three states have not issued state-wide stay at home orders and have lifted all regional orders. Seven states and territories never enacted stay at home orders.

Zero states/territories have all restrictions on nonessential businesses in-place; zero states/territories have lifted limited restrictions on nonessential businesses; seven states have lifted some restrictions; one state has regional lifting of some restrictions, thirty-five states have lifted most restrictions; two states have regional lifting of most restrictions, seven states have lifted all restrictions; two states have not closed nonessential businesses; and two states are special cases, lifting varies by locality.
